

# OFFICIAL RULES AND REGULATIONS

## ULTIMATE HOCKEY ROAD TRIP CONTEST 2026

**CONTEST DATES:** January 15, 2026 – February 28, 2026

### ELIGIBILITY

1. To be eligible to enter, you must be a resident of Canada and of the legal drinking age in the province/territory in which you reside in. You are not eligible to enter or win if you are:
